

C. National Trust for the Welfare of Persons with Autism, Cerebral palsy, mental Retardation and Multiple Disabilities

(i) The post of Chairperson, National Trust has fallen vacant on 24.10.2014 on completion of the tenure of the last incumbent Ms. Poonam Natarajan. With a view to appoint a regular incumbent to the post of Chairperson, Board of National Trust, the post was advertised six times since 10.08.2012. In response to the first advertisement dated 10.08.2012, no candidate was found to fulfil eligibility criteria for the post. In response to the second advertisement dated 20.09.2013, only two candidates were found to meet the eligibility criteria for the post. Therefore, the Searchcum-Selection Committee recommended for re-advertising the post. Against the third advertisement dated 18.03.2015, five candidates were found to meet the eligibility criteria. However, no candidate was found suitable for the post of Chairperson, Board of the National Trust. Thereafter, the fourth advertisement was issued on 03.07.2016, wherein only three candidates were found eligible by the Screening Committee which included two applicants who had applied against the third advertisement but not found suitable. Considering the fewer number of eligible applicants for the post in response to advertisements issued earlier, the eligibility criteria was relaxed and the National Trust Rules were also revised accordingly which were notified in April, 2018. Against the fifth advertisement, three candidates were found eligible. The proposal for seeking approval of ACC forwarded to DoP&T on 19.03.2020 for was

consideration. However, DoP&T vide their O.M. dated 25.08.2020 requested for reconsideration of the ACC proposal regarding filling up the post of Chairperson, National Trust and initiating the selection process of Chairperson, National Trust, afresh. Accordingly, with the approval of Hon'ble Minister (SJ&E), the process for filling up the post Chairperson, National Trust was started for the sixth time. A circular was advertised in the leading English and Hindi newspapers including Employment News for calling the applications from the eligible candidates for the post of Chairperson, National Trust; 04 candidates were found suitable for appointment to the post of Chairperson, National Trust. Thereafter, with the approval of Hon'ble Minister, again an advertisement was published in Employment News for calling the applications from the eligible candidates for the post of Chairperson, National Trust. The closing date for the receipt of applications was 14.04.2021.

(ii) In the meantime, as part of rationalizing the autonomous bodies of the answering respondent, Department of Expenditure suggested that National Trust may be wound up as a separate organization and its activities may be taken over by the Department. The answering respondent has sent a communication to Department of Expenditure on 08.06.2021 and a reminder on 16.9.2021 stating that National Trust carries out the crucial statutory functions in respect of four specified disabilities; hence the organisation

may be allowed to be continued in its present form. The matter is under consideration for a decision. In view of the facts stated herein above, the proposal to fill up the vacancy of Chairperson, National Trust could not be taken up, despite of efforts undertaken by the answering respondent.
